The "National Library and Information Services Infrastructure for Scholarly Content (N-LIST)" project, which is being jointly carried out by the e-ShodhSindhu Consortium, INFLIBNET Centre, and the INDEST-AICTE Consortium, IIT Delhi, offers i) cross-subscription to e-resources subscribed by the two Consortia, i.e. subscription to INDEST-AICTE resources for universities and e-Sho Through server(s) installed at the INFLIBNET Centre, the N-LIST project gives students, researchers, and professors from colleges and other beneficiary institutions access to electronic resources. Once they have been properly validated as authorized users through servers established at the INFLIBNET Centre, authorized users from colleges can now access electronic resources and download the articles they need directly from the publisher's website.

### **N-List: Four Components**

The project consists of four distinguished parts, including the following: i) subscription and provision of access towards chosen e-ShodhSindhu digital resources to technical organizations (IITs, IISc, IISERs, and NITs); ii) subscription and the availability of access to selected INDEST e-resources to selected universities; iii) subscription and provision of access to selected e-resources to government-aided colleges; and

Activities i) and ii) mentioned are jointly handled by the INDEST and UGC-INFONET. Activities iii) and iv) above are carried out by the INFLIBNET Centre, Gandhinagar

## Scope of the Study

The present study is confined to the colleges of Arts, Commerce and Science of Madurai District. There are many Consortiums in India but this study is mainly aimed at investigating the 'Use of e-resources of N-LIST programme by the college students'.

- 4. The pupils should hone their information-hunting abilities to make better use of the abundance of readily accessible digital sources of information.

The INFLIBNET N-LIST Project has been effectively and efficiently meeting the information needs of government- and government-aided colleges, as well as other beneficiary institutions. This study shows that in order to use N-LIST's electronic resources efficiently, user education programs, orientation programs, and workshops must be organized.
